



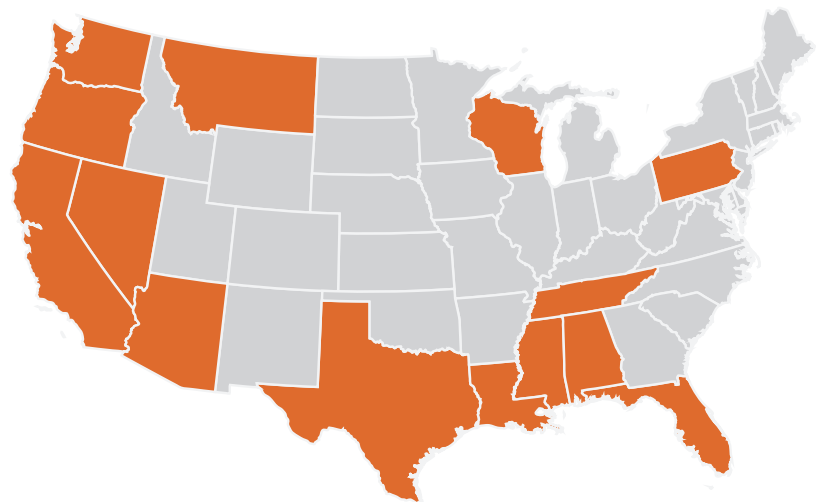

Judicial officers, treatment representatives, and administrative professionals can collaborate statewide, virtually, without administrative barriers.

DCCM offers:

Screening: Our Screening Tool includes a set of questions to assist the screener in determining eligibility for potential drug court clients and informs the screener of the candidate's risk factor. This information assists the screener in determining whether it is in the community's and justice's best interest to provide the defendant with treatment or alternative sentencing as opposed to incarceration.

Case File Management: The case file management tool displays individual client information including his/her case number, client type, treatment, phase, case manager, judge, and detailed client level information.

Continuing Care: This tool provides a way to gather post-discharge data for reporting and program analysis purposes. After discharge, DCCM monitors clients at 6, 12, and 24-month intervals.

Report Preparation: This tool generates reports based on the data entered, such as a drug test color report. The Staffing report can be printed in two formats: single or multiple clients per page. These reports can be exported into Microsoft or Excel.

Toxicology Management with Paracelsus: Paracelsus is a web toxicology management tool that has the ability to integrate with any offsite lab or case management system, allowing users to pass drug testing results to other applications. All the criteria needed to run a full lab are available and can be performed online. Paracelsus is cost-effective and performs accurate drug testing for your customers.
